## Mission and By Laws

### Mission

To provide the opportunity for all Oceanaire Men's Golf Association (OMGA) members to meet and play golf in a fun, social environment. The core principle is for golfers of all handicaps and capabilities to meet and routinely play together throughout the season, thereby providing an enjoyable social and competitive experience.

### By Laws

**Article 1:** The name of this association shall be Oceanaire Men's Golf Association (OMGA).

**Article 2:** The purpose of this association is to provide a consistent, organized program of golf for its members in coordination with the professional golf staff.

**Article 3:** All male golf members of the Greenbriar Oceanaire Golf Club, with a USGA handicap, (required) will automatically be members of the OMGA and will be able to play in Wednesday OMGA events.

**Article 4:** All members are required to abide by the conditions of the By Laws, USGA Rules, Greenbriar Oceanaire Golf Rules and Regulations and Standard Code of Golf Etiquette.

**Article 5:** The OMGA Committee will consist of a number of voting members, whose term of office will be two years with an effective date of January 1st. The Chairman and Treasurer will be selected by the OMGA Committee.

**Article 6:** The OMGA committee will meet on a monthly basis. Additional meetings can be scheduled by the Chairman, as deemed necessary. No business or policy decisions can be voted or agreed upon unless 50% or more of the committee members are present. The OMGA Committee will be responsible for establishing a schedule of golf events and other functions, as deemed necessary, in agreement and coordination with the professional golf staff.

**Article 7:** The Chairman will be responsible to see that all functions of the Committee are carried out and will appoint other committee members, as necessary, to other officer positions. The Committee will vote on all OMGA golf related issues.

**Article 8:** Money for all events will be on a pay as you go basis, which will be used for refreshments, weekly prizes, annual Shootout expenses, and other annual expenses.

**Article 9:** Amendments to the By Laws will be written by the Chairman and/or select Committee members. Recommended changes to the By Laws will be accepted from the general membership, which would then be formulated by the aforementioned Committee members and then presented to the entire OMGA Committee for approval. If approved, the changes will be presented to the membership at the OMGA Spring meeting for approval. If approved at the spring meeting the changes will be presented to the Board of Directors for final approval.

**Article 10:** This Article serves to hold harmless and indemnify the Oceanaire Men's Golf Association, its officers and participants, the Greenbriar Oceanaire Board of Directors, Greenbriar Oceanaire Homeowners Association, the Township of Ocean, Taylor Management, and all officials from all claims, damages, losses and injuries that may be incurred during all Oceanaire Men's Golf Association events and any other activities related to the Oceanaire Men's Golf Association
